a. 8:05 a.m. –James Dawley, Director of Construction for Habitat for Humanity, requested a variance for McCarty Ct. in Meadowlands Subdivision. In order for the possible future adoption of the road by the Road Commission, he is requesting a variance from the required grade of 8% to 7%. Shank discussed the request and recommends the Board grant the variance.

- i. Robinson Road from 3500' east of North Larks Lake Road then west to 3300' East of North Pleasantview Road for 2.46 miles. The public hearing was advertised in the Petoskey News Review. Proposed improvements include culverts, guardrail, trenching, HMA base crushing & shaping, aggregate base, concrete curbing, HMA paving, gravel shoulders, slope restoration, and pavement markings. No written comments were received prior to the public hearing and there were three calls for comment.
- ii. Old US-31 Highway from Horton Bay Road to Camp Dagget Road for .89 miles. The public hearing was advertised in the Petoskey News Review. Proposed improvements include culverts, ditch cleanout, aggregate base, HMA paving, gravel shoulders, slope restoration, and pavement markings. No written comments were received prior to the public hearing and there were three calls for comment.
- iii. Greenwood Road from McDougal Road to 200' east of Cedar Valley Road for 1.03 miles. The public hearing was advertised in the Petoskey News Review. Proposed improvements include culverts, drainage improvements, aggregate base, machine grading, concrete curbing, cold milling, HMA overlay, gravel shoulders, pavement markings, and slope restoration. No written comments were received prior to the public hearing and there were three calls for comment. Dennis Keiser, Bear Creek Township Supervisor, discussed the history of trying to get improvements on this and Haas Road completed for several years, and expressed appreciation in working with Shank and Horrocks on this.
- iv. Haas Road from Greenwood Road then to the south end for .29 miles. The public hearing was advertised in the Petoskey News Review. Proposed improvements include culverts, drainage improvements, excavation, aggregate base, HMA paving, gravel shoulders, pavement markings, and slope restoration. No written comments were received prior to the public hearing and there were three calls for comment.

ENGINEER-MANAGER REPORT: Shank discussed the following:

- Springvale Township approved a large project on Maxwell Road, approximately \$477,000. This will connect from where the federal aid project ended and go to Greenwood Road.
- Current year's bridge inspection included a recommendation for the pedestrian bridge over Bridge Street; make Bridge Street a one-way road from M119 to Beach Road.

- House Bill 6058, updating Public Act 152 for employee health care benefits, passed both the House and the Senate but has not been presented to the Governor.
- ESTA will become effective February 21, 2025, this is sick time for all employees along with other variables. There is current legislation proposed that may change this.
- Thanked the townships for getting project information to him early so the majority of this year's summer projects are already out for bids.

- Maxwell Road culvert lining on the township portion
- N. Ellsworth Road and Artesian Road paving projects
- Maxwell Road and Brutus Road federal aid projects
- Middle Village Road gravel project
- George Road reconstruction project in Bear Creek Township
- Littlefield Township has two ultra-thin projects
- March surplus equipment auction
- HMA sample certification course completed

EQUIPMENT SUPERINTENDENT REPORT: Shaler stated some of the new trucks have brought a learning curve for the mechanics but they are getting them figured out. The first of the new trucks will be brought to Truck & Trailer for upfitting by the end of the month, and two new companies have been found that may possibly be able to build the rims for the pavers.

ROAD FOREMEN REPORTS: Gray stated they have been plowing snow and doing tree work when not plowing. Zmikly stated they have primarily been doing snow removal and they have also been doing tree work on State Road.

FINANCE DIRECTOR REPORT: Kleeman briefly discussed the November Revenue and Expenditure Report as well as the November Michigan Transportation Funds received in January. She also stated the next meeting is February 21, 2025.

a. Dennis Keiser, Bear Creek Township Supervisor – Asked for an update on when the Click Road Bridge repair will occur.
