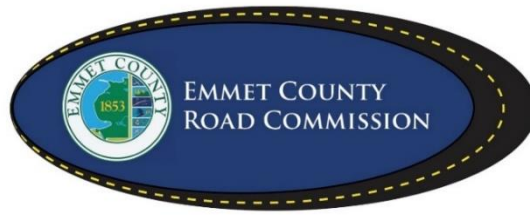

## **Culvert Materials ECRC Bid No. 25-07**

The Emmet County Road Commission will accept sealed bids for supplies pertaining to Culvert Materials. All Materials shall meet current ***MDOT Standard Specifications for Construction, 2020***.

Bids shall be submitted on the enclosed ECRC Culvert Materials Bid Sheet in a sealed envelope clearly identifying the bidder and marked "Culvert Materials".

The Culverts shall be made of galvanized steel (CMP). Bands shall be made of galvanized steel, be 24" length minimum, and include bolts.

Sealed bids will be received until **1:00 p.m., Monday, February 17, 2025**, by the Emmet County Road Commission at their offices located at 2265 E. Hathaway Road, Harbor Springs, MI, at which time they will be publicly opened and read aloud.

The Emmet County Road Commission reserves the right to accept or reject any or all bids, to waive irregularities in the bid procedure and to award in the best interest of the Emmet County Road Commission.
