ENGINEER-MANAGER'S REPORT: Shank discussed the following:

- Roof project is about 70% complete, extra mechanical work was required to replace some fittings for an additional \$1,500. There was quite a bit of wet insulation that was replaced. One change order for flashing and pipe insulation was added for about \$3,700. The contractor is expecting to be done by the end of next week.
- Lake Shore Drive Bridge Project June 17 is the start date as the bridge is expected to arrive later in the week with timber piles arriving a week earlier.
- Lake Shore Drive Road Project is expected to be in the MDOT June 7 letting with the earliest possible date to start of mid-August. Regular communication is happening with the newspaper in Cross Village so residents know what to expect as far as dates.
- Ellsworth Road should be finished paving today.
- Ice Control Sand should be finished in the Powers Pit tomorrow.
- Roy Road has been paved, waiting for paint
- McDougal Road guardrail should be finished today
- Moore Road should start next week.
- Robinson Road will probably start in July.

ENGINEER-TECHNICIAN'S REPORT: None

PERMIT/CAD TECHNICIAN'S REPORT: Godzik gave an update on Hathaway Road where DTE has staked out a gas line project. This is expected to start within two weeks and will be a pretty good-sized project. Advanced Communications & Data (dba ACD.net) will be installing a fiber optic line on East Brutus Road from US 31 to the Cheboygan County line on the north side of the road.

EQUIPMENT SUPERINTENDENT'S REPORT: None

ROAD FOREMAN'S REPORT: Zmikly stated they have been doing a lot of patching to get ready for the Zoo-de-Mack bicycle event, removing berms in McKinley Township, and prepping for dust control which is slated to begin in the next few weeks.

FINANCE DIRECTOR'S REPORT: Kleeman commented on the CRA Finance and Human Resources Conference attended the past two days and the ability to work directly with Department of Treasury representatives.

COMMISSIONERS' REPORT: Commissioner Hoffman inquired on dust control for our county and Shank confirmed this will take place during the next two weeks. He also stated Stump Road and Indian Garden Road turned out great.

Commissioner Williams inquired about focusing on berm removal and Shank confirmed that is the focus, but lately we have been focusing on MDOT projects, specifically shoulders. Williams discussed some ways to take the humps off and get fresh gravel on the shoulders.

PUBLIC COMMENT:

a. Ed Kuligowski, Pleaseantview Township Supervisor – Inquired on additional ARPA funds available for townships and Shank responded he has heard the County has approved another \$50,000. Dennis Keiser, Bear Creek Township Supervisor and David Boyer, Emmet County Administrator, both responded this amount is available with a deadline of September, applications are going out.

Commissioner Hoffman adjourned the meeting at 8:18 a.m.
