CORRESPONDENCE:

a. Notice was received of the Straits Area Council Meeting on Tuesday, February 13, 2024, at 9:30 a.m. at Audie's Restaurant in Mackinaw City. Shank, Kleeman, and Hoffman plan to attend.

ENGINEER-MANAGER'S REPORT: Shank discussed the following:

Monthly staff meetings have been scheduled to improve communication and efficiency;
 a work list has also been created.

- Bridge inspection and reporting requirements require us to start reporting on overloads. Our current permitting process allows for 25% overload allowances and there are four bridges that cannot handle this allowance. We will use Oxcart's transportation permit system to communicate with drivers in the next couple of weeks.
- Reimbursement for local road PASER ratings will be sought through TAMC.
- County Engineer's Workshop is February 6-8, 2024; both Shank and Horrocks will attend.

ENGINEER-TECHNICIAN'S REPORT: Horrocks gave the following update:

- Six projects are due for a February 5, 2024, bid opening.
- Couple of other projects are in the queue and will be ready to go out in March.
- Chip seal projects estimates are coming in slowly.
- Guardrail Safety Grant is ready, waiting on the call for projects.
- Critical Bridge Funding application will be next, focusing on bridge deck mill and fills.
- Centerline painting list will be developed shortly.
- Mileage Certification will be brought to the February 9, 2024, board meeting for approval.

PERMIT/CAD TECHNICIAN'S REPORT: Godzik discussed working with Tammy Doernenburg of Emmet County Planning and Zoning and the process both of them work through when a new request is received in her office. Specifically, a new request for an upgraded driveway access on Cedar Valley Road was discussed. Emmet County has implemented new zoning classification for home-based businesses and the new zoning doesn't fit our permit classifications. This request would currently be classified as multi-family (2-4 homes) permit and paving the access would be required. The county's new zoning will require the road commission to add additional permit classifications. Shank and Godzik will be reviewing the permit policy for needed updates.

It was <u>moved</u> by Hoffman, seconded by Williams, to approve the permit requirement of paving both entrances into the road right of way for 2943 Cedar Valley Road.

EQUIPMENT SUPERINTENDENT'S REPORT: Genson stated the following:

- New sign truck has been assigned a VIN, it may be here by the middle of February.
- Preliminary bids are being completed for the upfittings on the six new trucks that were approved at the last meeting.
- Roof bid is being worked on.
- No major breakdowns during the storm.

ROAD FOREMAN'S REPORT: Zmikly discussed the storm; they continue to plow and work on trees and brush.

FINANCE DIRECTOR'S REPORT: Kleeman stated the office has been busy with W-2's, 1099's and year end processes which will continue until the end of February with the annual audit. She also discussed the December MTF to be received in February.

COMMISSIONERS' REPORT: Commissioner Williams inquired on the status of the guardrail by the fairgrounds. Shank replied this is MDOT's guardrail and is in the process of being repaired.

PUBLIC COMMENT:

- a. Tammy Doernenburg, Emmet County Planning and Zoning Thanked the board for waiting to approve the permit on Anderson Road until further evaluation can be done and the consideration of moving trucks that will be using this site. She mentioned the City of Petoskey owns this land and may need to weigh in on this access. She also thanked Godzik and the staff for a very good working relationship; it helps her in working with Planning Commission and situations that may impact the roads.
- b. David White, Emmet County Commissioner Thanked the sign technician for replacing the stop sign and road sign on Hunter's Ridge that were stolen and he also thanked the crew for the plowing they have done.

Commissioner Hoffman adjourned the meeting at 8:43 a.m.
